

Pet Licensing Ordinance

95.15. RUNNING AT LARGE PROHIBITED
Any animal off the owner's premises and not leashed or under control shall be considered running at large.

95.16. LICENSE REQUIRED
Licenses shall expire April 1 of each year.

95.17. TAG REQUIRED
All licensed dogs and cats shall wear a collar and have the combined rabies/licensing tag firmly affixed thereto evidencing the license for the current period.

95.19. RABIES PREVENTION
Any dog or cat which has bitten any person should immediately be reported to the Police Department.

95.21. BARKING DOGS
It shall be unlawful for any person to keep or harbor a dog which habitually barks or cries.

95.24. VIOLATIONS
Any person violating any provision of this article shall be guilty of a misdemeanor.

95.25. SANITATION
Any person who owns, keeps or harbors a dog or cat shall have the responsibility for keeping their property clean of all fecal matter created by the animal.

Licensing Fees:

\$5/each spayed/neutered animal
\$12/each not spayed/neutered

Animal Permit Fees:

\$5/for three or more dogs/cats

License tags are good for one year.

\$12 plus vet costs

Second Offense:
\$28 plus vet costs

Third+ Offense:
\$59 plus vet costs

Not Licensed Animals:

First Offense:
\$17 plus vet costs

Second Offense:
\$44 plus vet costs

Third+ Offense:
\$72 plus vet costs
